## Closing the Door and Ending America's Greatness Michael K. Cantwell

The vitriol and nativism intensified with the arrival of immigrants with different skin colors and countries of origin as well as religions: "old stock Americans sought to preserve the traditional image of the country as primarily composed of descendants from Northwest Europe, especially of English Protestant stock."

In the late Nineteenth Century, a series of "Chinese Exclusion" laws limited and then barred immigration from China. The Immigration Act of 1917 <u>established quotas</u>, differentiating between "desirable" and "undesirable" immigrants based on nationality, race, and religion. Northern European Protestants were desirable, Southern and Eastern European Catholics and Jews were non-desirable, and non-Europeans were "highly undesirable."

The latter were the "shithole countries" of that era, to employ the degraded imagery of a president who would be king. Yet those immigrants persevered and became assimilated, for there is no such thing as "shithole" countries. There is no shortage of shithole people, however, many of whom are descendants of earlier waves of immigrations, people who forget where they came from, people who pull up the ladder after themselves, like Donald Trump and Stephen Miller and their minions and enablers. Southern and Eastern European immigrants were demonized in cartoons like this one from the May




16, 1923, edition of the Klan newspaper, Fiery Cross.

Yes, the torch of Lady Liberty symbolizes our freedom and represents our heritage, the compact with our parents, our grandparents, and our ancestors. It is that lady who gives us our great and special place in the world. For it's the great life force of each generation of new Americans that guarantees that America's triumph shall continue unsurpassed into the next century and beyond. Other countries may seek to compete with us; but in one vital area, as a beacon of freedom and opportunity that draws the people of the world, no country on Earth comes close.

This, I believe, is one of the most important sources of America's greatness. We lead the world because, unique among nations, we draw our people -- our strength -- from every country and every corner of the world. And by doing so we continuously renew and enrich our nation. While other countries cling to the stale past, here in America we breathe life into dreams. We create the future, and the world follows us into tomorrow. Thanks to each wave of new arrivals to this land of opportunity, we're a nation forever young, forever bursting with energy and new ideas, and always on the cutting edge, always leading the world to the next frontier. This quality is vital to our future as a nation. If we ever closed the door to new Americans, our leadership in the world would soon be lost.

## **The Murder Machine: Enriching the Rich By Killing the Poor** *Michael K. Cantwell*

"We have to start talking about this budget as a form of social and political murder. And the reason I use the word 'murder' is because they know that it's going to cause death." Bishop William Barber, interviewed by Amy Goodman and Juan González on Democracy Now.

What do you call people who would cut funding for the poorest and most vulnerable Americans in order to give more tax cuts to the richest and most entitled? Miscreants? Monsters? Murderers? Republicans? All of the above?

The greed goes beyond Trump and far deeper than anything Republicans have tried in the past. The last time Trump was in the White House Republicans passed the Orwellian-titled Tax Cuts and Jobs Act.

It had little impact on jobs, was grossly weighted to the wealthiest Americans, raised taxes on some poorer Americans, and increased the deficit by between <u>\$1.1-\$1.9</u> trillion, giving the lie to "<u>ludicrous</u>" claims it would pay for itself or even "create additional revenue for the government."

What Bishop Barber appropriately calls Trump's "big, bad, ugly, deadly, destructive, debilitating bill," just passed by House Republicans, is far worse. It <u>increases</u> the federal deficit by \$3.8 trillion while cutting Medicaid and other essential services by \$1 trillion.

Economics Nobel Laureate and former *The New York Times* columnist Paul Krugman <u>writes</u> that these cuts, especially those to Medicaid, "will cause immense, almost inconceivable hardship to the bottom 40 percent of Americans, especially the poorest fifth."



#### Killing Them Softly with Sleights of Hand

More than three-fourths of all Americans have a <u>favorable opinion</u> of Medicaid, including nearly twothirds of Republicans. That's not surprising, given that over half of Americans say that they or a family member has been helped by Medicaid and nearly two-thirds say that someone close to them has received help from Medicaid.

But 60% of Americans also <u>support</u> conditioning Medicaid benefits upon work. The Supplemental Nutrition Assistance Program (formerly "Food Stamps") already requires able-bodied individuals aged 18 to 54 who are without dependents to work in order to receive benefits.

Republicans know it would be politically damaging to cut funding to Medicaid in order to give additional tax breaks to billionaires and multi-millionaires. But they also know something that those Americans who support work requirements do not, namely, you *can* cut benefits for people who *are* working by making sufficiently onerous to document that. In fact, as <u>The</u> <u>New York Times</u> reports:

Most of the people expected to lose coverage would be eligible for the program but unable to prove it under the law's strict paperwork standard.

Let that sink in for a minute: most of the people who will lose coverage under Trump's big, bad, ugly, deadly, destructive, debilitating bill will actually have worked the requisite hours. They just won't be able to prove it.

#### the lack of health insurance is intractably linked to premature, unnecessary deaths.

A pre-Obamacare <u>study</u> at a time when 45 million Americans were uninsured estimated that the lack of health insurance led to 45,000 Americans dying prematurely and unnecessarily. A later <u>study</u>

In fact, as Professors Pamela Herd and Donald P. Moynihan explain in a recent <u>guest essay</u> published in *The Times*, after Arkansas adopted such work requirements in 2018:

"nearly all of the people who lost coverage had met the requirements. They simply couldn't manage the paperwork to prove it."

Or as Benjamin Sommers, a professor of health policy at Harvard and the lead author of a study on the Arkansas work requirements <u>puts it</u>:

What this is really about is producing budget savings . . . This is not savings through improved efficiency, or more people going to work. It's savings by kicking people out of the program who are mostly eligible.

These sleights of hand are how Republicans hope to avoid the political damage that would result from their savage exploitation of the most vulnerable among us in order to reward the least needy and least deserving:

Republicans are opting for opaque cuts, which will shed millions of eligible beneficiaries by overwhelming them with pointless paperwork and other needlessly complicated administrative requirements.

And the staffing cuts directed by Trump pal Elon Musk have resulted in a lack of help with Medicaid/ Medicare application problems. People have reported waiting more than five hours on hold and then having the call dropped.

The Congressional Budget Office estimates that 7.6 million people will become uninsured as a result of this ugly bill. And studies have demonstrated that

examining the impact of Medicaid expansion when it first became available under Obamacare estimated that Florida's failure to expand Medicaid to 800,000 eligible Floridians resulted in 2,776 unnecessary deaths during a four-year the period 2014-2017.

Because the Florida Republican Party refuses to expand Medicaid, Thousands more Floridians have died since then. Trump's big, bad, ugly, deadly, destructive, debilitating bill will also have a <u>devastating impact</u> on rural hospitals, hundreds or which are already at an immediate risk of closing. Many of those who will lose coverage will be children, which is not only heartless but economically brainless, as Prof. Krugman explains:

Providing health care to children isn't just about social justice and basic decency. It's also good economics. Children who receive adequate care grow up to be more productive adults. Among other things they end up paying more taxes, so Medicaid for children almost surely pays for itself."

But those returns come in the future, and the modern Republican Party does not care about the future of our children . . . or our Republic or our democracy, or our planet, for that matter.

They are laser focused on the present and on how they continue afflicting the most afflicted in order to comfort the most comfortable without attracting too much attention.

### **Trifecta: Donald Trump and the Reverse Midas Touch** *Michael K. Cantwell*

Donald Trump has the reverse Midas Touch. In 2021, his support of Republicans David Perdue and Kelly Loeffler helped deliver the U.S. Senate to Democrats by electing Reverend Raphael Warnock and Jon Ossoff, respectively, in Republican Georgia. The following year his support of Herschel Walker in the midterms helped Democrats increase their Senate majority.

Since being reelected, Trump has rescued seemingly doomed campaigns of foreign leaders and may even have helped elect a pope.

After Justin Trudeau resigned as Canada's prime minister and leader of its Liberal Party in January, Pierre Poilievre's Conservative Party was expected to win the national election by double digits. But Trump's delusionary insistence it was inevitable Canada would become our Fifty-First state, coupled with the punitive tariffs he'd announced, helped Mark Carney's Liberal Party to a surprise victory. The damage to conservatives was so bad that Poilievre even <u>lost</u> the parliamentary seat he'd held since 2004.

"Down Under," center-left Prime Minister Anthony Albanese became the first Australian PM to win reelection in 21 years, making a "<u>stunning</u> <u>comeback</u>" and defying Australia's so-called "incumbency curse." As in Canada, the losing candidate (Peter Dutton) also lost a parliamentary seat he'd held for over two decades.

Albanese also had <u>Trump to thank</u> for the surprise win. Albanese specifically rejected Trump and his policies while Dutton and his party were seen as identifying with Trump: "Analysts argue that mirroring Trump switched from a political positive for Australian conservatives to a negative after Trump imposed global tariffs."

#### Pope Leo XIV

Pope Francis, a staunch advocate for the vulnerable and downtrodden, was widely referred to as a "voice for the voiceless." With his death, and with Trump back in the White House, ultra-conservatives who opposed Pope Francis were plotting to "<u>make the</u> <u>Vatican great again</u>." Of course, that's not what happened.

Cardinal Robert Francis Prevost (now Pope Leo XIV) appears to share his predecessor's concern for the vulnerable and voiceless. As Trump and his minions step up their demonization and abuse of immigrants, we can take heart in knowing that the papacy will continue to be a voice for the vulnerable and the voiceless.

There was every reason to fear the pendulum would swing back with Pope Francis's passing. There's a natural tendency for such swings – Francis succeeding Benedict was a quantum shift, as was Trump 45 succeeding Obama, Biden succeeding Trump, and Trump 47 succeeding Biden. So how did Pope Leo happen?

One <u>report</u> claims that the conclave was not looking for a counterweight to Trump, but it's hard to believe the specter of Donald Trump was not in the room with the cardinals. And to the extent that he swayed yet another the election, we owe him our gratitude.

## **Stagflation** *Michael K. Cantwell*

GDP has dropped from 2.4% in Biden's last quarter to -0.4% in Trump's first quarter, and this is before the Trump tariffs have taken effect.

Companies that sell popular products and services to consumers, including Mattel, Chlorox, and Denny's, are <u>reporting</u> both that Trump's tariffs will force them to raise their prices and that sales are already down as consumers are reducing purchases in anticipation of those higher prices.

The University of Michigan Survey of Consumer Confidence just <u>reported</u> that consumer sentiment fell for the fifth straight month since Trump entered office and now is only slightly above its all-time low. Republicans as well as Democrats are expecting higher inflation and unemployment, which

The Conference Board's Consumer Confidence Survey <u>reported</u> that "consumers' expectations for the future are at a 13-year low." More than 70% of Americans expect a recession and inflation expectations reached their highest level since November 2022. The Fed is facing the same Hobson's choice faced by the Fed back in the late 1970s and early 1980s as well as more recently in 2022. If they lower interest rates to reduce the likelihood of a recession, they increase the risk that inflation will spike. And if the increase interest rates to fight inflation, they risk causing a recession.

Americans In the earlier instance. suffered stagflation – interest rates that went as high as 20%, inflation that never fell below 10% for over 3 years and peaked at 14.8% as well as unemployment that reached 10.8%. While many economists predicted that the 11 interest rate increases imposed by the Fed in 2022-23 would cause a recession, not only was inflation cut from 9.1% to 3% in a year, but unemployment experienced only a slight uptick, from 3.6% to 4.2%. See Deconstructing the Inflation Bogeyman, The Delray Democrat, September 2024. We not only avoided a recession but growth remained strong because of Bidenomics.

Today, however, we have a one-man wrecking crew in the White House. Stagflation will be resurrected, and with a vengeance.
