Modeled on Franklin Delano Roosevelt's famed Civilian Conservation Corps and established by executive action, the ACC will employ and train 20,000 people "for good-paying careers in the clean energy and climate resilience economy."

According to the <u>Bureau of Labor Statistics</u>, the median salary for green-energy jobs ranged between \$63,750 and \$84,030 in 2021, versus \$45,760 across all jobs.

But the ACC is not simply (or even principally) about "good jobs." It represents President Biden's commitment to the generations that will otherwise inherit a planet that is on life support.

Gun violence is another issue that has a wildly disproportionate impact on Gen Z. Since the mass shooting at Columbine High School in 1999, more than 356,000 students have experienced gun violence at schools in 386 school shootings. Cries of "we must do something" were followed by years of doing nothing.

On Friday, September 23, 2023, Biden did something. He announced the formation of the Office of Gun Violence Prevention. The Office will be headed by Vice President Kamala Harris, who pursued gun safety measures when she served as Attorney General of California. It flows from legislation introduced in the House this March by Representative Maxwell Alejandro Frost and cosponsored by Senators Chris Murphy and Richard Blumenthal.

Representative Frost (FL-D) is the youngest member of Congress and the first from Gen Z. He explained the importance In his comments introducing President Biden, he explained:

As the youngest member of the United States Congress and the first member from Gen Z, I'm often asked what got me involved in this work, and the answer is quite simple. I didn't want to get shot in school."

#### Gen Z Has Biden's Back

A recent <u>CBS News Poll</u> in which Biden trails Trump by 1 point is being trumpeted by the SCLM as evidence that voters think Biden is too old. It's not the first time the SCLM has attempted to justify its obsession with Biden's age by claiming that it is merely reporting what voters think.

This is disingenuous, for, as the SCLM well knows, it creates as much as it reports on voter attitudes . . . not only about Biden's age but about inflation and even the economy, "<u>It's the Media, Stupid</u>."



# A Century of Republican Incompetence and Racism Versus Democratic Competence and Inclusion

## **Republicans Cause the Great Depression Democrats Create the Safety Net**

1929-1932: Republicans control both Congress and the White House in 1929 as the country careens into the Great Depression. The government does nothing to alleviate suffering as unemployment reaches 25% and millions become homeless: "Hoover feared that providing direct aid to people in need would cause them to lose their incentive to work hard."

The next two times Republicans will control both Congress and the White House will be in the runup to George W. Bush's Great Recession and after the election of Donald Trump.

**1933-1944**: FDR announces a "New Deal" that includes a massive public works program, a "safety net" for desperate Americans, and regulation of the economic titans that caused the Great Depression. In his final State of the Union, FDR explains "that true individual freedom cannot exist without economic security and independence" and proposes a <u>Second Bill of Rights</u>.

"We cannot be content, no matter how high that general standard of living may be, if some fraction of our people—whether it be one-third or one-fifth or onetenth—is ill-fed, ill-clothed, ill-housed, and insecure." The dream dies with FDR's death 2 months later.

## **Democrats Expand the Safety Net Republicans Resort to Red-Baiting and Racism**

**1964**: Democrats pass Medicare and Medicaid. Ronald Reagan, shilling for the AMA, warns that if Medicare passes, "you and I are going to spend our sunset years telling our children, and our children's children, what it once was like in America when men were free."

**1964-1965**: Democrats pass the Civil Rights and Voting Rights Acts. LBJ warns "we have lost the South for a generation." It is a gross underestimate.

**1968**: Dick Nixon launches his "Southern Strategy," using racist dog whistles to capture the presidency.

**1981-1992**: Reagan opens his campaign with an appeal to "States Rights" in the same Mississippi county where the Klan murdered Goodman, Schwerner, and Chaney. He promotes racist tropes: "welfare queens driving Cadillacs" and "strapping young bucks buying T-bone steaks with Food Stamps." Bush follows suit with Willie Horton. The Solid South flips, the Raw Deal replaces the New Deal, and the federal debt quadruples

**1993-2001**: Bill Clinton raises taxes and creates 23 million jobs during his tenure. The annual budget shows a surplus for his last three years in office.

## **Democrats Keep Fixing Republicans Messes**

**2001-2008**: George W. Bush ignores CIA warnings regarding Osama bin Laden. He invades Afghanistan and comers but loses bin Laden in the mountains. He launches a \$3-trillion war against Iraq based on lies and in violation of international law. He spies on Americans unlawfully. He doubles the federal debt.

He signs two tax cuts benefitting the wealthiest Americans. He tries but fails to privatize Social Security. He bungles the response to Katrina. He lets banksters run wild and they cause the worst economic crisis since the Great Depression, Four million Americans lose their jobs and 10 million (dispropoltionately POC) lose their homes.

**2009-2016**: Republicans monolithically oppose Barack Obama's efforts to repair the economy. Only three Republican vote for The American Recovery and Reinvestment Act of 2009. It averts a second Great Depression, but another 4 million jobs are lost before the economy begins to recover. The U.S. credit rating is downgraded and the government shut down in phony debt ceiling crises engineered by Republicans. Still, 11 million jobs added by Obama

Democrats pass the Affordable Care Act, insuring 20 million previously uninsured Americans and saving tens of thousands of lives. Bin Laden is killed.

2016-2020, Behold the Beast: Dismissed as a joke by the craven, clueless corporate media, Donald Trump presides over the most ruinous presidency in American history. His single legislative achievement is a tax cut for plutocrats and multinationals. Inheriting the greatest postwar expansion, he adds nearly as much debt in 4 years as Obama added in 8. His incompetent response to COVID exacerbates the death toll and plunges the country into a Second Great Depression. He loses 9.3 million jobs in his final year, becoming the first president to preside over a net job loss during his tenure.

**2021-23**: Democrats pass the American Recovery Plan and Inflation Reduction Act without any Republican votes. Biden signs the largest infrastructure bill in decades, the first gun safety legislation in nearly three decades; the biggest expansion of vetei ans' benefits in over three decades, and an investment in microchip production to make America more competitive with China.

Biden adds 13 million jobs in 30 months (a monthly average double that of Clinton and triple that of Reagan), unemployment flirts with its lowest rate in 54 years, and Black unemployment drops to its lowest level ever.

# Are We Headed Toward Privatizing Education in Florida?\*

You have to give it to him. Gov. Ron DeSantis' scheme to weaken our public schools in favor of increased private, religious and home schooling has worked. As expected, when he eliminated income restrictions on school vouchers, there was a surge in applicants this summer. Heck, even wealthy folks can have the state pick up the tab for all or part of their children's private schooling.

Florida may be on the trajectory toward total privatization of our public schools.

What was originally a strategy to help poor children exit failing schools is now a dark design to destroy public education, supplant it with private schools, and bill the taxpayers.

June S. Neal of Delray Beach is a former columnist for the As of Aug. 18, 2023, school vouchers, officially the Florida Tax Credit Scholarship Program, siphoned off 407,000 students from our public schools while the rest of the 430,000 applications were being reviewed and more were coming in. DeSantis called this "... a monumental increase over last year's enrollment of nearly 250,000 students."

It's also a monumental decrease in funding for public education.

If it appears to be an incongruent strategy by a governor who frequently praises Florida's public education, it is. But it's also political insurance against fallout from both sides. DeSantis aims for positive media coverage of his public-school governance, while he simultaneously props up substandard institutions that use the same Christian nationalist playbook he thinks will advance him to the presidency.

Vouchers have a shameful past. In the 1950s and '60s, Southern states used them to skirt the Brown v. Board of Education Supreme Court decision that declared school segregation unlawful. The result was white flight to private schools, paid for with vouchers that drained taxes from the wretched public schools the Black children were left in. Vouchers were nothing more than Jim Crow in a new shirt. DeSantis is using them for a different kind of segregation — severing his straight, white Christian philosophy from our modern democratic ethos.

Floridians are facing an existential threat to their schools and their democracy. The Education Law Center warns: "Already underfunded public school districts will be financially gutted. The potential for harm to local public-school districts, which serve most Florida students, is extreme."

And so is the harm to our kids.

A years-long investigation by the Orlando Sentinel and reviews by major independent organizations found too many voucher schools offer a substandard education.

Reporters uncovered mostly Christian-based curricula, much of which was anti-science, anti-LGBTQ, racially biased and almost completely unregulated.

DeSantis has already deformed Florida's public education with his racist, homophobic legislation. And private, religious schools (we don't have enough information on home schools) are fertile spots to indoctrinate even more students with his straight, white and Christian ethos. "For the 2023 school year, there are 1,448 religiously affiliated private schools serving 298,720 students in Florida," according to Private School Review.

The Sentinel reported, "Some private schools in Florida that rely on public funding teach students that dinosaurs and humans lived together, that God's intervention prevented Catholics from dominating North America and that slaves who 'knew Christ' were better off than free men who did not."

The reporters found, "The books are rife with religious and political opinions on ... abortion, gay rights. They disparage religions other than Protestant Christianity and cultures other than those descended from white Europeans." And yet, as of February 2023, only 27.2% of students using the voucher program are white. Further, 81.4% of the schools accepting vouchers are officially religious.

And the vouchers are supporting actively anti-LGBT schools. In 2020, "14% of Florida's nearly 147,000 scholarship students attended private schools where homosexuality was condemned or, at a minimum, unwelcome," reporters discovered. Several private schools that received millions of dollars in vouchers promoted conversion therapy for LGBTQ students.

So, besides bigotry, what else are taxpayers getting for their money?

Lack of accountability in unregulated schools, for one. "Private elementary and secondary schools in Florida are not licensed, approved, accredited or regulated" by the state, according to the Florida Department of Education." The arbitrary appropriation of money is also crippling our schools. In 2021, the Southern Poverty Law Center found: "No state comes close to Florida in the allocation of public funds to private schools ... decreasing per pupil funding by 12% from \$9,799 to \$8,628 while the rest of the country's schools increased their spending by 9.6%." Florida ranks "seventh from the bottom of all states in per pupil funding at \$9,346."

Public education is fundamental to democracy. It's the nation's singular institution structured to cohere a hugely heterogenous population into Americans. Whatever deficits our schools have should be fixed with the tax dollars we are now diverting to private schools that are operating on principles most Americans have worked for decades to eradicate.

## Keep Trump (the Gift that keeps Giving) on the Ballot

Citing Section 3 of the 14th Amendment to bar Trump from running was first floated after the Jan. 6 committee hearings exposed the depths of his attempts to overthrow the election. It was generally regarded as unlikely to succeed.

For one, it's unclear whether Trump would be considered among "former officers of the United States." Second, he could argue that drafters of the amendment intended "insurrection or rebellion" to apply only to sustained battlefield war. That's a stretch, given the plain meaning of Section 3, but the ultimate interpreter of the language would be the Supreme Court, three of whose members were appointed by Trump and six of whom are conservative Republicans.

Things have changed this year, however. After four indictments, each one increasingly damning, Trump is not only unelectable, but his nomination is likely to cause a level of down-ballot destruction not seen since 1964. It's hardly surprising that two Federalist Society professors authored a report claiming that the 14th Amendment applies to Trump, nor would it be surprising to see the Supreme Court agree. They've all gotten what they needed from Trump.

With Trump, loyalty is a one-way street. It would be satisfying to see him hoisted on his own petard. Still, I hope he is not barred from the ballot. It might be the only way we can save both our democracy and our planet.



# "Oh, You Can't Scare Me, I'm Sticking with the Union"



When Woody Guthrie wrote *Union Maid* in June 1940, more than 30% of American workers belonged to unions. The right to unionize was won only after a century of bloody battles in which workers were beaten by Pinkertons and thugs hired by factory owners.


In 1935, Congress passed the National Labor Relations Act ("NLRA"). Part of FDR's New Deal, it gave employees the right to form and join unions and required employers to bargain collectively with unions selected by a majority of the employees.

Unions helped create an American middle class that was the envy of the world. They reduced inequality because "they raised wages more for low- and middle-wage workers than for higher-wage workers, more for blue-collar than for white-collar workers, and more for workers who do not have a college degree. more for low- and middle-wage." They also benefitted non-union workers in the same and related industries by setting a benchmark for employers anxious to avoid unionization efforts.


The converse is true as well. Union membership peaked in 1954 at 35 percent. By 1983 it had dropped to 20.1 percent and in 2022 it was 10.1 percent, according to data published by the Bureau of Labor Statistics.



Membership in private sector unions fell even more dramatically over that period, from 16.8 to 6.0 percent during the years between 1983 and 2022:



The inverse relationship between union membership and concentration of wealth at the <u>top</u> is evident in a chart included in a report recently issued by the Treasury Department. The <u>tripling</u> in union membership (blue line) that followed the creation of the NLRB was accompanied by a similar decline in the income share of the top 1 percent (red line).



#### How Did This Happen?

That's what George W. Bush asked his Treasury Secretary Hank Paulson after the Banksters crashed the economy in 2008. As Paulson later recalled in his <u>memoir</u>, "It was a humbling question for someone from the financial sector to be asked – after all, we were the ones responsible."

What happened? Many factors were cited in symposium published by the <u>Institute for</u> <u>International Economics</u>: increased competition, both domestic and international; additional members of workforce (white-collar, Southern, and women) less favorable to unions; deregulation of transportation industries; decline in pro-union attitudes among workers and increased resistance by employers to unions.

Resistance by employers seems to be the principal cause, aided and abetted by government hostility to unions, with the principal villain being the genial snake-oil salesman who became our fortieth president and quickly set about replacing FDR's New Deal with his own Raw Deal.

Overpaid CEOs were lionized as they cheated, squeezed, and discarded workers, many of whom continued to vote Republican because Reagan's racist tropes effectively misdirected their anger. Reagan stood on its head the philosophy that had taken America from the Great Depression to the Great Society: We are all in this together. Government became a dirty word while greed was celebrated.

#### The Good News: Unions Are on the Rebound

The <u>National Labor Relations Board</u> reports that the number of union representation elections increased nearly 60 percent in 2022. Moreover, a rule change recently promulgated by the NLRB will eliminate some of the dirty tricks companies employ to defeat unions.

Previously employers undermined unionization drives by firing organizers, delaying the election, bombarding employees with disinformation, and engaging in other illegal tactics. After they won the election, they were given slaps on the wrist. Under the new rule, such tactics are punished by the immediate recognition of the union.

As part of its Work and Education Survey, Gallup has been polling attitudes toward unions since 1936, and support for unions in 2022 was the highest since the mid-1960s.

In addition, the Center for American Progress reports that support for unions has reached a level not seen since the 1960s. Although support for unions is over 50% for all generation cohorts, the support increases with each subsequent generational cohort:

Gen Zers are the most supportive of unions, with a mean approval rating of 64.3, compared with 60.5 for Millennials, 57.8 for Gen Xers, and 57.2 for Baby Boomers.

Moreover, and perhaps contributing to this trend, each generation is increasingly diverse: "While 75.5 percent of Baby Boomers and 65.2 percent of Gen Xers are white, according to 2020 ANES data, only 59 percent of Millennials and 52.4 percent Gen Zers are white." The racists who chant "You will not replace us," are fighting a losing battle. Like them, I have spent my life in the majority, but unlike them, I do look forward to being replaced.

<u>A recent report</u> from the Bureau of Labor Statistics highlights the benefits of union membership, citing the following data from September 2022:

- Union workers earn (salary + benefits) \$53.20 <u>per</u> hour (versus \$38.37 for non-union workers.
- Nearly all (96%) union members have access to health care coverage, versus only 64% for non-union workers.
- Union members have nearly six times (64% versus 11%) the access to guarantee to defined benefit plans, which guarantee a predictable income during retirement.

# How the SCLM Resembles Frank Drebin of Police Squad Michael K. Cantwell

*Naked Gun*  $33\frac{1}{3}$  ends with a hilarious sequence during which Lt. Frank Drebin solidifies his status as the archetypical schlemiel. Chasing a criminal at the Academy Awards, he ends up on stage with a group of male dancers accompanying a performance by Pia Zadora.
